3. A student dismissed for a disciplinary reason will not receive a refund of the activity fee.
4. I/We acknowledge that proper safety equipment, including, but not limited to, proper headgear, knee, shoulder, shin, and elbow pads, may be required to be worn and used properly by my/our child in order to participate in GCA activities.

I/We understand that, and authorize, my/our child's image may be photographed or filmed and may be used in Video/CD/DVD presentations, social media forums, and/or printed publications for promotional purposes. These may include publications and/or websites owned or maintained by GCA or its affiliates but will not be used for the purposes of direct financial gain.
6. I/we acknowledge that even with the best observance of rules and supervision injuries are still a possibility

I/We hereby relinquish any and all liability for any cause of action for personal injury, property damage, or wrongful death occurring to my/our child arising out of his or her participation in GCA sanctioned events and/or activities. The terms of this waiver, release, assumption of risk and indemnity agreement shall apply through August 31, 2019, and by this agreement any such claims, rights, and causes of action that my/our child may have are hereby relinquished and my/our child (or parent(s) / guardian(s)) do/does so on behalf of my/our and my/our child's heirs, executors, administrators and/or assigns.

I/We understand, acknowledge and assume all risks inherent in activities and sporting events, and understand that said sports and activities involve risks to my/our child's person including bodily injury, partial or total disability, permanent or partial paralysis, and death, and damages which may result, and that I/we have full knowledge said risks, and that these risks and dangers may be caused by the negligence of my/our child or the negligence of others. It is further acknowledged that there may be risks and dangers not known to GCA, to us, or are not reasonably foreseeable at this time.

I/We acknowledge and understand and assume the risks, if any, arising from the conditions and use of the facilities used in GCA/XZone sanctioned activities and related premises and acknowledge and understand that included within the scope of this waiver and release is any cause of action, arising from the performance, or failure to perform maintenance, inspection, supervision or control of said areas and for the failure to warn of dangerous conditions existing at said facilities.

I/WE ACKNOWLEDGE THAT I/WE HAVE READ THE ABOVE TERMS AND HAVE NOT RELIED UPON ANY REPRESENTATIONS OF RELEASEES, THAT I/WE ARE FULLY AWARE OF AND HAVE BEEN ADVISED OF THE POTENTIAL DANGERS OF THE ACTIVITIES AND/OR SPORTING EVENTS DESCRIBED ABOVE, AND SIGN THIS AGREEMENT VOLUNTARILY, UNDERSTANDING THAT IT IS NECESSARY TO ALLOW THE AMATEUR EVENTS DESCRIBED ABOVE TO EXIST IN THEIR PRESENT FORM AND PRESENTATION.
